



After completion of the project period, the retention of equipment(s) purchased out of the project grant by the private agencies /NGOs is not allowed as per the prevailing Govt. of India instructions. Hence, the Pvt. Institutes/ NGOs involved in the instant project shall abide by the instructions issued/ to be issued by the Department in this regard from time to time.

(i) The institute / college has to ensure laying of the Annual reports and Audited Accounts of the Institute on the Table of the House within nine months of the close of the succeeding financial year of the grantee organization in accordance with Rule 238(6) of the GFR 2017; thus timely submission of the record is mandatory for the grantee institute/college  
13. (ii) it is applicable for all the Private and Voluntary Organizations or Societies registered under the Registration of Societies Act, 1860 which are receiving one-time assistance/ non-recurring grants of Rs.50 lakh and above.

14. The retention of the equipment purchased out of the project grant after completion of the project in respect to Private Institutions will be as per the instructions/modalities/terms & conditions issued by the Department of Bio-technology keeping in mind overall public interest in accordance to instructions issued by Ministry of Finance vide OM dated 30.09.2021.

The other terms and conditions governing the financial sanction will remain unaltered.
