Mr Donnet D'Souza welcomed the members and requested Fr Vincent Pinto the finance officer to lead the team into prayer

Rev. Fr Praveen Martis S.J Principal of the College welcomed the members and gave his initial remarks

The coordinator of anti-ragging cell highlighted students' grievances related to behaviors indulging in ragging and drug abuse in the previous academic year and also asked members to give their valuable suggestions to create awareness among students and make ragging free campus. He also initiated the need of forming revised procedure for students to file online anti-ragging affidavit.

During the meeting, it was discussed that the coordinator can send a notice through the principal to all directors, heads of the departments, class guides (PG), and staff welfare officers (PG) on the procedure to file the online anti-ragging affidavit by students as per the mail sent on 25 November 2021

The coordinator can contact all the class guides (PG) and staff welfare officers (PG) and ask them to instruct them to file the online anti-ragging affidavit and for that Google forms can be prepared and sent to all students

Once students file the online affidavit, they will receive a reference number and they are supposed to forward it to the coordinator by filling up the Google forms

Members of the committee suggest that there can be regular activities conducted on campus to create awareness of anti-ragging or to decrease behaviors among students which leads to indulging in ragging

During admission as well orientation programme a session can be organise to highlight the importance of anti-ragging and students required follow the guidelines

If any students experiences or find any such behaviors inside or outside the campus, can bring to the notice of student representatives, class guides, HOD, or Deans.

The block directors can take up such cases and forward them to the coordinator for an inquiry and submit the report to the director and principal

Students who are found to be guilty, do not follow the rules and regulations or indulge in such behaviors can be taken strict action on them as per UGC guidelines.

The information regarding anti-ragging can be put up on the notice boards in the form of collages, and posters as per UGC guidelines



Anti-ragging Cell

Measures taken by the college to prevent ragging in the campus

1. **Anti-ragging Cell meetings** on regular basis are held to discuss on activities and awareness programmes for students to prevent from ragging inside and outside the campus
2. **Anti-ragging Inquiry Committee:** This committee will meet to identify the issues amicably and to take legal action against students if who are found guilty of the same.
3. **Counselling Department:** The department promotes student friendly campus through counselling services like improving relationship with family, friends, room-mates, helping them to take right decisions about one's personal life, to deal with conflicts and situations like loneliness, depression etc.. Counsellors play significant role in the campus handling student's issues through careful listening and empathetically handling their issues, which prevent from doing so.
4. **Student's Grievance Cell:** This cell works to prevent students address their grievances. The students can state their grievance regarding any academic and non- academic matters within the campus through Class guides or Block Directors. In such cases students will be called for an inquiry and adequate
5. **IC Cell and Women forum:** the aim of these cells to empower women through skill enhancing activities and also take initiatives to prevent from to be victims of sexual abuse or sexual harassment.
6. **Value Education and Gender Equity courses:** These courses are mandatory for all first UG students in the curriculum. These courses educate students on societal values, family values, professional ethics, and morality as a part of Gender studies, sex and gender, adolescence health education, gender equality, women employment and women health. As a whole the course hub on peaceful contentment of women and men in the society. It enables the students to maintain peace and harmony with in our own self and to maintain a universal human goodness, promote them to learn about non-violence, global harmony, and human right.
7. **Orientation sessions and awareness programmes on anti-ragging-** enable students to be assertive to say NO to ragging and also create awareness on the legal provisions and UGC guidelines through class guides (UG) and Social Welfare Officers (PG)
8. **Life skills education and training, personality development programmes** are conducted to enhance students coping mechanisms, self awareness, to be competent to face the challenges of life and to be assertive towards risk behaviors
9. **Co-curricular activities through associations, department fests and sports events** help students to develop problem-solving, reasoning, critical thinking, creative thinking, communication skills, enhance talents and collaborative abilities. Sports activities establish the qualities of discipline and maintain physical and mental health.

10. **Social service and social work activities through SAHAYA (UG) Rural immersion programme (PG) to create social consciousness, inculcate social values and students to understand their social responsibilities**
11. **Guest speakers:** Guest speakers are invited to talk about the areas of Drug abuse, mental health, career guidance, women health issues, Human Rights etc
12. **Posters /boards are displayed** at the entrance and notice boards in every blocks
13. **Guidelines and instructions** are mentioned in college calendar and college website where students access to it
14. It is mandatory for **Students/parents to give consent** about not indulging in ragging activities inside the campus or during their studies
15. Students have to fill the **Online affidavit for anti-ragging** to get reference number which is to identify any issues related ragging and accurate action can be taken

U.G.C. REGULATIONS ON CURBING OF RAGGING IN HIGHER EDUCATION INSTITUTIONS

“INSTITUTION” means a higher educational institution, a college, imparting education beyond 12 yrs of schooling to a degree.

Ragging means the following:

1. Any conduct whether by words spoken or written or by an act which has the effect of teasing.
2. Treating or handling with rudeness any other student.
3. The effect of teasing, treating or handling with rudeness of any other student.
4. Indulging in rowdy or undisciplined activities which cause or is likely to cause annoyance.
5. Hardship or psychological harm or to raise fear or apprehension thereof in a fresher or a junior student.
6. Asking the students to do any act or perform something which such student will not in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student.

How to go to the website and required procedure to be filled

The revised procedure:

Step 1: A student will submit his/her details on the same web sites- [www. antiragging.in](http://www.antiragging.in) and www. amanmovement.org as before.

Step 2: The student will receive an e-mail with his/her registration number and web link. The student will forward the link to the e-mail of the Nodal Officer in his/her university/college.

(The student will not receive PDF affidavits and he/she is not required to print and sign it as used to be the case earlier).

Step 3: The Nodal Officer in the university/college can click on the link of any forwarded e-mails that he/she will receive from any student of his/her college to get the list of those students who have submitted Anti Ragging Affidavits/Undertakings in his/her college. The list will be updated every 24 hours.

ACTION BY THE COLLEGE:

As per the above mentioned conduct, any individual or group of students belonging to the institution, indulge in this action inside or outside the campus & while commuting is punishable as per the provisions of the Act of central & state Governments, which is considered ragging as a cognizable offence under the law on par with atrocities against women, all ill-treatment to person belonging to the marginal section of society.

All information regarding this issue, shall be given to the below mentioned authorities in person or in writing or through suggestion box.

Dear Madam/Sir,

As you are aware, in pursuance to the Judgment of the Hon'ble Supreme Court of India dated 8.5.2009 in Civil Appeal No. 887/2009, the UGC notified "Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009" and in compliance of the 2nd Amendment in UGC Regulations, it is compulsory for each student and his/her parent/Guardian to submit an online undertaking each academic year at either of the two designated web sites, namely, www.antiragging.in and www.amanmovement.org.

As part of UGC's initiative towards reduction of compliance burden of its stakeholders, UGC has revised the procedure for students to file online Anti Ragging Affidavit.

The revised procedure is as follows:

Step 1: A student will submit his/her details on the same web sites (www.antiragging.in and www.amanmovement.org) as before; read and confirm that he/she and his/her parents/Guardians have read and understood the regulations on curbing the menace of ragging. He/She will confirm & agree that he/she will not engage in ragging in any form. (Step 1 is the same like before).

Step 2: The student will receive an E MAIL with his/her registration number and a web link. The student will forward the link to the E mail of the Nodal officer in his/her university/college. **(Please note that the student will not receive pdf affidavits and he/she is not required to print & sign it as used to be the case earlier).**

Step 3: The Nodal Officer in the university/college can click on the link of any forwarded e mails that he/she will receive from any student of his/her college to get the list of those students who have submitted Anti Ragging Affidavits/Undertakings in his/her college. The list will be updated every 24 hours.

Step 2: The student will receive an Email with his/her registration number and a weblink. The student will forward the link to the Nodal officer in his/her University/college.

Step 3: The Nodal officer in the University/college can click on the link of any forwarded emails that he/she will receive from any student of his/her college to get the list of those students who have submitted Anti Ragging Affidavits/Undertakings in his /her college. The list will be updated every 24 hours.

You are also requested to display the **email address** and **contact number of the Nodal officer of Anti Ragging** of your University/ College in your website and campus areas like admission centre, departments, library, canteen, hostel and common facilities to create awareness about the revised procedure for students to file online Anti Ragging Affidavit.

You are also requested to create an E-admission booklet or brochure, E-leaflets giving details on guidance in case of ragging to admitted students instead of print/ hard copy.
