The meeting started with a prayer led by Rev. Fr Vincent Pinto, SJ, Finance Officer of the College.

The Chairperson, Rev. Fr Melwin Joseph Pinto, SJ accorded a warm welcome to the expert members.

In his opening remarks, Rev. Fr Melwin Joseph Pinto, SJ placed on record the leadership and services of the former Rector and Chairperson of the Governing Body, Rev Fr Dionysius Vaz, SJ towards building strong systems and facilitating several new infrastructural, academic and research initiatives. He expressed his concern over the impact of the unrelenting pandemic on the academic calendar and scheduled programmes and events of the academic year. He highlighted the imperatives that the NEP has placed on education, in general, and higher education, in particular. He placed before the house the challenges anticipated in the process of implementation of NEP with a special reference to St Aloysius College (Autonomous), keeping in mind the values of equity, inclusiveness and multidisciplinarity in terms of the campus culture and curricular framework as well as the Jesuit character of making higher education holistic. He also referred to the specific challenges of the context of delivering education in a highly polarized society of the coastal belt of

Karnataka. He invited the members to contribute their valuable suggestions to take the institution forward in the context of the NEP.

A short audio-visual presentation on the recent developments in the College was presented by the Principal. The following are some of the highlights of the presentation:

- Rev. Fr Dionysius Vaz, SJ, the former Rector and Chairperson of the Governing Body has been elevated to the position of the Provincial of the Karnataka Jesuit Province and Rev. Fr Melwin Joseph Pinto, SJ has taken over as the new Rector and Chairperson of the College Governing Body.
- College performance in the various annual National Level Rankings like NIRF, India Today, The Week Hansa and Outlook were presented.
- The College has been awarded with the Green Institutional Award for the year 2019-2020.
- Under the UGC Paramarsh Scheme, out of the 5 College under the College mentorship, 3 of the Colleges have gone for NAAC accreditation process. Milagres College, Mangaluru has received B++ Grade by NAAC.
- During the pandemic, more than 50 Free Online Certificate Courses were offered to our students and the public by different faculties of the College. 106 webinars have been conducted during the pandemic on contemporary topics of interest to the students and the public. 13 Certificate courses with excellent feedback have been upgraded and offered to the public for a nominal fee.
- UGC has approved 2 B.Voc. Programmes to be started in the year 2021-22. They are B.Voc. (Renewable Energy Management) & B.Voc. (Software Development)
- All the UG and PG Curricula have been brought under Learning Outcomes Based Curricular Framework (LOCF) from 2020-21.
- All the UG and PG departments have designed and drafted their specific Visions and Missions to be displayed in the respective departments.
- A unique rural entrepreneurship initiative has been initiated by the College to bring together the rural producers and consumers in the digital platform for marketing the rural products and promote rural entrepreneurship. The initiative has been named- Aloysius Jaala Santhe.
- Under the UGC-STRIDE Scheme 14 Major and Minor Research Projects on the Topic
  of the study of the cultural diversity of coastal Karnataka have been selected with a
  grant of Rs. 22, 85,000=00.
- The list of students who received Summer Fellowships and the list of staff who have been awarded the VGST research grant were mentioned- Dr Lyned Lasrado, Dr Ambareesh and Dr Sana Sheik.
- The number of staff that completed PhD during 2019-20 is 24, and 37 staff members have qualified NET/SLET Examinations.
- More than 1500 students and staff of the College have enrolled to Coursera and edX online Certificate programmes and more than 1200 of them have completed at least one programme. Coursera has issued 2,000 additional lincenses to the College.

- Intensive peer group study/training was organized for NET/SLET examinations for the staff under the leadership of the faculties of Sciences and Humanities.
- 6 National/International level Seminars/Webinars were conducted during the year.
- An intensive workshop on the revised NAAC accreditation framework was organized by the College IQAC. Dr Ganesh Hegde, the regional coordinator of NAAC, Bengaluru was the Resource person.
- The College IQAC in collaboration with IPSR Solutions organized a 5 Day intensive workshop on OBE for all the staff to impart in depth knowledge on the Bloom's Taxonomy for preparing a comprehensive Question Bank to obtaining the attainment levels of students.
- An exclusive Dean for Placements, Training & Careers has been appointed with exclusive spaces for conducting career guidance, training and placements.
- Dr Ratan Tilak Mohunta & Dr Alwyn D'Sa have brought out a customized Text book of English for the Semesters III & IV for General English students.
- Elections to the Students' Council and the Investiture Ceremony were held online.
- Campus Bird Count was conducted by students with guidance from the staff and 35 specific species of birds were identified and registered on the campus
- 3 Intensive workshops and seminars/webinars were conducted on the awareness and challenges and opportunities of NEP were organized with nationally acclaimed resource persons.
- College Community Radio, Radio Sarang along with select NGOs organized an intensive work shop (Community Awareness) on Waste Management and Vermiculture/compost in households using three pots.
- The rank holders of the 2016-2019 batch were felicitated at a grand event on 23-12-2020. 73 UG/PG rank holders received Merit certificates/medals and cash prizes during the event.
- "Triumph"- an award ceremony to felicitate the students with academic excellence was held on 07-01-2021. Scholarships and Merit certificates were awarded to students.
- A unique Virtual Get together of the retired members of the staff was held on the Foundation Day of the College. This initiative has been widely acclaimed by the retired staff.
- The Principal of the College, Rev. Dr Praveen Martis, SJ is the official member of the NAAC panel of assessors of the autonomous Colleges. He also has been awarded the "Outstanding Community Leader of Mangaluru" by the International Institute of Public Policy, USA".
- 7 students from SUNY, Cortland University have enrolled for a unique Virtual Internship in Healthcare Management from our College.
- All the libraries of the College have been installed with state of the art RFID automation system.
- The Sanidhya Hall has been installed with the state of the art AV solution and videoconferencing facility and a high end video screen has been installed in the LCRI hall.

 A state of the art computer laboratory has been designed in the AIMIT Centre with the generous contribution by Sri Prem Vatsa and Sri Michael D'Souza, eminent alumni of the College.

#### AGENDA 1: GBM 27:

To record the proceedings of the Twenty Sixth Governing Body meeting held on 08.08.2020 and the action taken report

The proceedings of the Twenty Sixth Governing Body Meeting were placed before the house by the member Secretary, Rev. Dr Praveen Martis, SJ.

#### Resolution: Approved

The following observations were made by members:

- The members expressed their appreciation for the impressive recording of the recent developments of the College in the form of the video.
- Prof. Valerian Rodrigues congratulated the College for the performance of the College in various academic, co-curricular and extra-curricular domains gearing itself up to the changes taking place in the field of higher education.
- He also noted that there were a few spelling and typing errors in the book of proceedings and agenda which could be avoided in the future.
- Members sought information regarding the status of the deemed to be university proposal and its follow up in the recent time.
- Members sought clarification on the status of the proposal to start the new B. Sc
   Programme in Visual Communication.
- Information was also sought on the follow up of the initiative to start Integrated
   Programmes with Legal Studies and the current stand of the BCI.
- Dr Anil Pinto elaborated the procedural issues and concerns regarding the Undergraduate Programme in Education (B.Ed.) and Integrated Programme in Education.
- Prof. Rajendra Chenni expressed his appreciation to the College for initiating dialogues on the NEP and for the initiatives to make the institutional curricula more multi-disciplinary in nature.
- Dr Shakeel who joined on Zoom (virtually) advised the College to start seriously working on implementing NEP in a phased manner. He highlighted the need to enhance research, innovation and start-ups on a priority basis as it is the immediate concern of UGC. He informed the Council that the College needs to have a concrete action plan for capacity building initiatives. He also mentioned that there was a high chance of getting the status of the deemed to be university to the College.
- Dr Hemalatha Balram expressed her appreciation for the accomplishment of the College in the recent times.

Principal expressed his gratitude to all the esteemed expert members for showing their concern and solidarity with the institution and offering their timely counsel. He also thanked the chairperson for giving the appropriate direction to the proceedings of the meeting.

### Action Taken:

- Efforts are taken to avoid obvious errors in spelling and other linguistic errors in the proceedings, reports and proposals in the agenda. The document has been subjected to language review by experts from language departments.
- Principal briefed the members on his visit to the UGC and the MHRD ministry offices and expressed confidence that the proposal for deemed to be university would be approved soon.
- He also informed the members that the proposal to start B.Sc. (Visual Communication) has been sent to the university and as the said nomenclature is not in the official list under Mangalore University, it has been sent to the state Higher Education department for review and approval.
- He briefed the house that the proposal to start integrated programme with legal studies has been still kept on hold considering the uncertainties regarding the provisions available to apply for the same.
- The Task Force on the implementation of NEP in a steady and phased manner has made a study regarding the modus of incorporating / integrating programmes in education/legal studies.
- Dr Shakeel Ahamed's suggestion to proactively enhance the research, innovation leading to viable start-ups has been taken seriously. The Innovation Day for the year 2020-21 was held in the month of May. Two innovative ideas chosen by the jury last year have been promoted and taken forward through financial assistance from the College. An exclusive state of the art space for the Incubation centre has been created with adequate facilities. The College has identified a few more innovative ideas to be promoted leading into viable start-ups. An exclusive position of the Dean, Research and Innovation has been put in place last year for the promotion of this initiative.

The college has sent a proposal under NIDHI project of the Central Government for creation of St Aloysius Incubation Centre.

The College has expedited the efforts to pursue the status of our proposal for the deemed to be university by personally visiting Delhi regularly in the past few months and talking to the officers from the MHRD and UGC. College is eagerly looking forward to receive the approval very soon.

#### AGENDA 2: GBM 27:

# To review the examination results of Undergraduate and Postgraduate courses of the academic year 2019-20

The results were placed before the house by the Controller of Examinations.

### Resolution: Approved with the following observations:

- Concern was expressed regarding the dwindling number of students in the PG Programme in Bio-Informatics, Economics and Psychology.
- Principal mentioned that these departments needed support in terms of promotion/marketing. He clarified that the numbers had increased in Psychology for the current academic year compared to the previous year.

- He also explained to the house the strategy to identify 50 institutions that have been
  the feeders to these programmes and involve them in enhancing/promoting the
  enrolments in the coming years.
- The house also identified the 'medium of instruction' as a variable posing a challenge for enrolments in some departments.
- It was also suggested to evolve alternative terms for the division of the Commerce streams. The term, B.Com. (General) could be avoided.

#### **Action Taken:**

The College has identified 50 institutions wherefrom students have been regularly enrolling for PG programmes from the past several years and has promoted our programmes by sending flyers and unique curricular features. Respective departments also have taken concrete steps to promote their programmes.

The number of applications to Economics and Psychology is showing a significant improvement this year.

#### AGENDA 3: GBM 27:

To approve the list of eligible candidates for awarding the Degree/Diploma certificates who have completed the degree in September, 2020 Examinations

Resolution: APPROVED

**Action Taken:** The list of eligible candidates along with the ledger mark/grade sheets were dispatched to the University for verification and for preparing the Degree Certificates. The College has received all UG/PG Degree Certificates duly signed by the Vice Chancellor.

#### AGENDA 4: GBM 27:

To consider and approve the proposal to constitute the Parent - Teacher Association (SACPTA) and its proposed constitution

Principal presented the proposal to the house.

In the discussion that followed members expressed their apprehensions and concerns regarding constituting a formal and legalized.

Certain anomalies in the draft of the agenda also were brought to the notice of the house. Members suggested that the College take into consideration the concerns expressed by the experts and create an informal body of parents and teachers representing the various sections of the demography of College/Society.

Resolution: The College was authorized to take appropriate decision in this regard.

**Action taken:** Taking into consideration the concerns expressed by the eminent members of the Council, the College decided to constitute a parent-teacher body consisting of an informal group of parents and teachers representing all sections of the College.

The College places on record the valuable counsel offered by the members.

AGENDA 5: GBM 27:

To consider and approve the institutional Green (environment) and Placement Policies

- The draft of the policies was placed before the Council by the Principal.
- It was suggested to distinguish between the technical and the ethical dimensions of the policies, especially, the placement policy.
- There was a general feeling that the institution must guard against indiscipline among students regarding the guidelines guarding the placements.
- There was a general appreciation for the environmental policy which highlighted the social responsibility of the institution.
- Principal placed before the house the initiatives of the College in creating the Centre of Environmental Concern (CEC) in addition to the already existing Centre for Social Concern (CSC) with an exclusive designated Coordinator.
- It was suggested that the College take up pilot projects beyond the campus on the riverine and coastal belts and their ecosystems involving NGOs, staff and students of the College.

Resolution: Approved

Action taken: Implemented

- College has created a consortium of NGOs and like minded Colleges to address the concerns caused by the dump yard at Pachanady. The College has taken the lead in this initiative.
- The Centre for Environmental Concern (CEC) has been active planning and executing several webinars, physical activities to put in place systems for solid waste management and e-waste management in consultation with companies and NGOs. The Students' Council has been taking an active role in these activities and
- As a part of the Sahaaya, the social volunteering initiative, students have been assigned specific areas/spaces and assignments facilitating a green, clean, garbagefree, zero carbon and zero waste campus and its surroundings.

To consider the proposal for including a mandatory course in Research Methodology along with an exclusive module on Research Ethics in all the curricula of Postgraduate Programmes, preferably during the first 2 semesters

- Members brought to the notice of the house, the large scale deception occurring in the field of research studies and publications. The initiative of the College to introduce the mandatory course in research methodology and ethics was
- It was suggested to propose a common course for Humanities and Social Sciences. It exhance the interdisciplinary of the courses.

- Members suggested that common/appropriate weightage to the course in terms of credits/grades may be evolved.
- It was advised to initiate the Research Methodology and Ethics course in the final year of the undergraduate programmes or under open elective courses so that students who intend to take up research in the future would be benefited by this initiative. Under NEP, the four year undergraduate programmes will have a mandatory research components in the final year. Members felt that it would be the best time to introduce research culture/attitude among students. This initiative could be started by allotting faculty mentors to students of the undergraduate programmes.

#### Resolution: Approved

Action taken: All Postgraduate departments have designed courses in Research Methodology and Ethics in consultation with their respective Boards of Study. The same has been reviewed and finalized. The finalized courses have been proposed in the Academic Council meeting held recently and has been approved.

#### AGENDA 7: GBM 27:

To consider and approve the proposal to introduce the Internship/Apprenticeship Embedded Degree Programme according to UGC Guidelines under Banking, Financial Services and Insurance Sector(BFSI) from the academic year 2021-22

- The proposed semester-wise structure and credit allotment of the entire programme along with the mandatory Internship/Apprenticeship for a full semester duly approved by the Academic Council was presented to the house.
- The proposal was appreciated by the members. It was also suggested to identify other areas of studies for such embedded programmes in future.
- Members suggested to create more collaborations and MoUs with industry related to more number of areas of study.

#### Resolution: Approved

**Action taken:** The structure of the Programme, duly approved by the College Academic Council and the Governing Body was sent to the University.

The structure has been sent to the concerned Board of Studies of the university. As this Programme is designed recently and the university does not have this nomenclature of the programme in the official list, it is informed to us that, the proposed nomenclature needs to be approved by the department of higher education of the state.

The department of Commerce has prepared an elaborate syllabus for the said Programme in consultation with its BOS and other experts and the finalized syllabus was placed before the Academic Council held recently and has been approved.

The new programme has been approved by the Mangalore University recently subject to allotment of credits as per Mangalore University regulations and that the new programme be implemented from the very first semester of the academic year 2021-22.

The following observations were shared by the esteemed members:

- 1. Intensive preparations/coaching for competitive examinations like NET/SLET need to be provided to PG students by respective departments.
- 2. Students are to be mapped according to their aptitude and orientations and provided training for various competitive examinations conducted by national and international agencies.
- 3. Students could be mandatorily trained for the Prelims of UPSC Examination at the end of their undergraduate programmes. Department of Political Science can facilitate the same.
- 4. The already established Museum and Archives need to be upgraded/made more comprehensive by pooling together all scattered credentials/artefacts/ documents in one centralized space as those would provide a major attraction and a glimpse of the 140 and odd years' heritage of the College and its influence in the city, state and the country.

The meeting concluded with the expression of gratitude by the Principal. Action taken:

1. College has already started mandatory coaching for NET/SLET Examinations in all PG departments. Due to this initiative many PG students have qualified the eligibility tests and some of them have passed the test after the first semester itself.

- 2. Faculty-wise Peer Coaching initiatives have been started wherein experienced staff and faculty who have already qualified the examinations train the other staff who are yet to qualify. This initiative has resulted in many of our faculty qualifying these eligibility tests in the last year.
- 3. The department of Human Resources has created a comprehensive questionnaire to be administered to students soon after their admission and effective mapping has been done of students of the first year undergraduate and postgraduate students. On the basis of the findings, appropriate groups will be made and extensive training will be given to prepare them for the various national and globally recognized competitive examinations.
- 4. Provision has been made to train undergraduate students keen on pursuing UPSC examinations to enroll to the Evening Batches of SAICS- St Aloysius Institute of Civil Services. The earlier coaching programme for the prelims conducted by the department of Political Science and Humanities will be continued.
- 5. The Management has come out with a new plan of action to space the Museum, Archives and the SACCA/Alumni Association Office in the proximity to the College Chapel so that all the sites of tourist attraction are in the vicinity. The work of bringing archive and museum related objects and documents will commence shortly.
- 6. Based on the official Press Release communicated by the Bar Council of India dated 16.06.2021, it has been informed that the moratorium imposed on starting programmes in Legal Studies has been lifted after two years. It is also mentioned that the BCI's role in approval of such programmes comes into force only in the third stage of such a process. It has been strictly instructed to the state level authorities to go through the proposals diligently before issuing the NOC to institutions. The College would like to follow the process as per guidelines shortly. We would like to thank Dr Anil Pinto, our esteemed member for sharing the copy of the Press Release.
- 7. The college has upgraded the implementation of the E-governance policy through our digital technology provider Linways Technologies for ensuring secure and transparent procedure in admission, online attendance system, subject allocation of faculty, Examination duty allotment, Internal assessment mark entry system, payment of fee, generation of marks /grade cards, results and statistics related to attainment levels of students.
