The BOS meeting began with the silent prayer. Dr. Manuel Tauro, Dean department of Commerce, welcomed the members of the BOS. Dr. Shobha, HOD BCom regular presented before the board the minutes of last BOS meeting.

Agenda No.1: Implementation of NEP syllabus in BCom programmes:

Semester I

Subject 1: Financial Accounting:

1. Shift module No.5, titled 'Emerging trends in accounting' to second semester.

Reason for change: to bring balance between the theory and problem related units

- (ii) Accounting standards: Board suggested to include only fundamentals of standards in the unit. Dr. Manuel Tauro had suggested to add standard setting process in the unit accounting standard.

Subject 2: Management Principles and Applications
Board suggested to reduce the content. Therefore under unit Staffing - content was reduced by removing motivation fully and by retaining only 2 theories of leadership.

Subject 3: Principles of Marketing:
Board suggested to reduce the content under unit consumer behaviour.

Subject 4: Open elective course:

1. Subject financial literacy - there were no suggestions, Board accepted the same syllabus.
2. Subject: Managerial economics - few changes were made and board accepted the changes.
3. Accounting for everyone - Dr. Santhosh Pinto suggested to make the subject simple and easy for the students of other discipline. Concepts from PU syllabus can be introduced.

Semester II

1. Subject: Advanced Financial Accounting:
Suggestions: to shift 'Insurance claims for loss of stock & loss of profit' to 1st semester as a last unit.
Shift unit "Emerging trends in accounting" from first semester to second semester.

2. Business Mathematics: Board accepted the changes made in maths syllabus of adding probability and set theory to the syllabus.

(ii) Subject: Investing in stock markets - No changes were suggested.

(iii) Public finance - a few changes were suggested and will be made by economics department staff members.

Semester III & IV: Structure was presented and approved in the BOS.

Semester V & VI:

Suggestions about Internship: Board suggested that in the 5th semester instead of internship students can be offered projects. As offering internship for all students is practically difficult and the companies and number of student ratio does not match - Dr. Suresh and Dr. Santhosh.

As Internship is given in 2 semesters, in 6th semester 50 marks can be given for report submission.

Suggestions by Dr. Manuel Taurus:

Blom CA, ACAA programmes can be called as Blom Vocational programmes. Blom integrated with CA can be named as Blom with Accounting Standard and Tax. Blom ACAA programme can be named as,



Bcom with International Accounting & Finance. These two programmes of Bcom will be shown to the University as to Bcom Vocational programmes.

Suggestions by Mr. Praema, student representative. Mr. Praema suggested that computer based subjects should be provided to students.

In response to student's suggestions Dean mentioned about Computer paper in 4th semester.

Suggestions by Dr. Sudha. Baldya - conducting financial accounting practical classes with the lab facilities is difficult for most of the colleges because of lack of infrastructure.

Scheme of examination :-

Question paper pattern was changed to suit the practical question paper like financial accounting. Under section C marks were increased to 15 from 10. The changed question paper pattern for the semester end examination is as below:

Part A - Answer any 5 (five) out of 7 (seven) questions : $5 \times 2 = 10$ (Sl. No 1 to 7 questions)

Part B - Answer any 4 (four) out of 6 (six) questions : $4 \times 5 = 20$ (Sl. No 8 - 13).

Part C - Answer any 2 (two) out of 3 (three) of the following : $2 \times 15 = 30$ (Sl. No 14 to 16).
Total 60 marks.
