- c. Unit III Significance of Anatomy to be included under introduction
- d. Unit III modification of gene action by growth hormones, senescence to be removed since it is related to plant physiology.
- e. Unit IV Interdisciplinary aspects in reproductive biology to be included
- f. Incorporation of contribution of Prof K. R Shivanna, retain Maheshwari P and remove the rest embryologist since their contribution is in some other field.
