MEMORANDUM OF UNDERSTANDING

I. PREAMBLE

In accordance with a mutual objective to promote further cooperation between the United States of America and India, North Dakota State University (NDSU) and St. Aloysius College (Autonomous) (SAC), hereby jointly enter into a bilateral linkage, focusing on the development of their institutions' programs. They will jointly develop and implement activities to improve their capacities to serve their respective clientele in the United States of America and India. This linkage is developed based upon the institutions' commonality of interests and their belief that a linkage between them would strengthen their joint and individual capacities.

II. THE OBJECTIVES

The objectives of this linkage are to development cooperative activities. The activities may include, but are not limited to, the following:

- 1. Build collaborative research and educational programs:
- 2. Develop exchange and professit val development programs for students, staff and faculty;
- 3. Create opportunities for faculty example and faculty doctoral upgrade;
- 4. Create cultural exchange through mutual assistance in the areas of education and research;
- 5. Share new technologies and new methods of teaching and management through extension and other programs:
- 6. Seek funding opportunities or joint activities which provide mutual benefit to each institution's teaching, research and outread grams;
- Exchange academic information, materials and programs;
- 8. Co-organize joint conference and workshops and training programs:
- Create an environment for student exchange; and Other cooperative activities as appropriate.

III. PROGRAM MANAGEMENT

North Dakota State University and St Aloysius College (Autonomous) jointly agree to develop and establish provision and implementation that will serve the mutual interest of both institutions.

It is understood that the details of joint activities, conditions for utilization of results achieved, and arrangements for specific visits, exchanges and other forms of cooperation will be negotiated for each specific type of activity.

It is also understood that financial arrangements will be negotiated in each specific type of activity and will depend upon the availability of funds. Each party agrees to seek financial resources for supporting the exchange and collaboration. The contact and exchanges between the two parties shall be on the basis of friendship, equality, and mutual assistance.

The linkage program at North Dakota State University will be supervised by the Office of International Student and Study Abroad Services. The program at St. Aloysius College (Autonomous) will be under the jurisdiction of the Principal of SAC and managed by the Dean of International Programs.

IV. TERMS OF UNDERSTANDING

This understanding is effective on the date of the last signature hereto and will remain in effect for an initial period of five years and may be extended for a period as mutually agreed by both parties. The agreement can be terminated by either institution by giving one year's notice to the other party. The projects or work.
