

MEMORANDUM OF UNDERSTANDING for cooperation between St Aloysius College (Autonomous) and Universidad Católica de Cuyo



Preamble

In accordance with a mutual objective to promote further cooperation between India and the Argentina, St Aloysius College (Autonomous), located at St Aloysius College Road, Hampankatta, Mangalore 575003, Karnataka, India, represented by its Principal - Fr Dr Praveen Martis SJ, and Universidad Católica de Ca. o, located at Av. José Ignacio de la Roza 1516, 5400 San Juan, Argentina, represented by its Sector - Dr. Claudio Marcelo Larrea Arnau, agree to cooperate in regard to program, based in the principle of reciprocity. St Aloysius College and Universidad Católica de Cu. o are referred to individually as a "party" and collectively as "parties".

This Memorandum of Understanding (herein and called MOU) serves as a legal document for both parties to establish and develop the bilderal relationship. This will help enhance research and educational processes at both institutions and thereby build on their academic quality and outreach programs.

Objectives of the Agreement

- 1. Both parties will work together to develop mutual agreements for cooperation based on their respective academic, scientific and research needs. The activities in which specific agreements may be developed include
- Working toward offering dual-on tree, student-exchange and study-abroad programs;
- Developing and implementing joint research programs, including creating proposals for funding purposes;
- c) Co-organizing joint seminars, workshops and training programs;
- d) Sharing knowledge obtained om projects worked on together;
- e) Enhancing quality and outreach educational programs with increased networking;
- n Other cooperative activities as appropriate.
- 2. St. Aloysius College and Universidad Católica de Cuyo jointly agree to develop and establish provisions for program implementation that will serve the mutual interests of both institutions.
- 3. It is understood that the details of joint activities, conditions for utilization of results achieved, and other forms of cooperation will be negotiated for each specific type of activity.





It is also understood that financial arrangements will be negotiated in each specific type of activity and will depend upon the availability of funds. Each party agrees to seek financial resources for supporting the exchange and collaboration. The contact and exchanges between the two parties shall be on the basis of friendship and mutual assistance.

The related work done at St Aloysius College will be under the jurisdiction of its Principal and supervised and managed by the Dean of the International Programs. The program at Universidad Católica de Cuyo will be under the jurisdiction of Secretaría de Extensión y Relaciones Institucionales - International Cooperation Office.

Terms of Understanding

This understanding will be effective on the date of the last signature hereto and will remain in effect for an initial period of five years and will be an a-renewed for further periods of equal time, if not amended or canceled by either party. The agreement can be terminated by either institution by giving one six-month not ce to the other party. The projects or work started before the termination would come to its regical end without any negative impact to either party. This will be amicably agreed upon by both parties.

The activities under this understanding will be reviewed on an annual basis as mutually agreed and plans for future activities will be developed each year immediately following the review.
