


# **MEMORANDUM OF UNDERSTANDING**

between

### I. PREAMBLE

In accordance with a mutual objective to promote into er cooperation between India and the United States of America, Le Moyne College, Syracuse, New York, VSA, hereinafter referred to as "Le Moyne" and St. Aloysius College (Autonomous), M. g. Vore, India, hereinafter referred to as "St. Aloysius", hereby jointly enter into a bilateral linkage, focusic son the development of their institutions' programs. Le Moyne and St. Aloysius will jointly develop and impless ent activities to improve their capacities to serve their respective clientele in the United State of America and India. This linkage is developed based upon the institutions' commonality of interests an otheir clief that a linkage between them would strengthen their joint and individual capacities.

### II. OBJECTIVES

The objectives of this linkage are to develop long term cooperative activities. The activities may include, but are not limited to, the following:

- 1) Develop collaborative research and educational programs
- 2) Develop exchange and processional development programs for students, staff and faculty
- 3) Conduct seminars and workshops
- 4) Cultural exchange through munial assistance in the areas of education and research
- 5) Share new technologies and new methods of management through extension programs
- 6) Seek funding opportunities for paint activities which provide mutual benefit to each institution's teaching, research and outreach regrams

## III. PROGRAM MANAGEMENT

Le Moyne College and St. Aloysies College (Autonomous), jointly agree to develop and establish provisions for program implements and will serve the mutual interests of both institutions.

It is understood that the letails of joint activities, conditions for utilization of results achieved, and arrangements for specific visits, exchanges and other forms of cooperation will be negotiated for each specific type of activity.

It is also understood that financial arrangements will be negotiated in each specific type of activity and will depend upon the availability of funds. Each party agrees to seek financial resources for supporting the exchange and collaboration. The contact and exchanges between the two parties shall be on the basis of friendship, equality, and mutual assistance.

The linkage program at Le Moyne College will be under the jurisdiction of the President of Le Moyne and and supervised by and managed by the Dean of Madden School of Business. The program at St. Aloysius will be under the jurisdiction of the Principal of St. Aloysius and managed by the Dean of International Programs.

#### IV. **TERMS OF UNDERSTANDING**

This understanding is effective on the date of the last signature hereto and will remain in effect for an initial period of five years and may be extended for a period as mutually agreed by both parties. The agreement can be terminated by either institution by giving one six months notice to the other party.

The activities under this understanding will be reviewed on an annual basis as mutually agreed and plans for future activities will be developed each year immediately following the review.

#### V. **SIGNATURES**

The parties hereto, through the duly authorized presentatives, he eby agree to the provisions and terms of this linkage agreement.
