



# MEMORANDUM OF UNDERSTANDING

between

St Aloysius Institute of Management & Information Technology (AIMIT), St Aloysius College (Autonomous) - Mangalore, India

and

IQS School of Management, Universitat Ramon Llull - Barcelona, Spain

### I. PREAMBLE

In accordance with a mutual objective to promote further cooperation between India and Spain, St Aloysius Institute of Management and Information Technology (AIMIT) of St Aloysius College (Autonomous), Mangalore, and IQS School of Management of Universitat Ramon Llull, Barcelona, hereby jointly enter into a bilateral linkage, fecusing an the development of their institutions' programs. St Aloysius College (Autonomous) and Universitat Ramon Llull will jointly develop and implement activities to improve their capa tries to serve their respective clientele in India and Spain. This linkage is developed based upon the matitutions' commonality of interests and their belief that a linkage between them would sales, when their joint and individual capacities.

# II. OBJECTIVES

The objectives of this linkage are to develop long-term cooperative activities. The activities may include, but are not limited to, the following.

- 1) Develop collaborative research and education programs;
- 2) Develop exchange and professional development programs for students, staff and faculty;
- 3) Conduct seminars and workshops
- 4) Share new technologies and new methods of management through extension and other programs;
- 5) Seek funding opportunities for joint activities which provide mutual bene it to each institution's teaching and a compared programs;
- 6) Co-organize joint conferences and workshops as well as training programs;
- 7) Support staff and students from the two institutions for studying towards degree and non-degree programs; and
- 8) Other cooperative access as appropriate.

## III. PROGRAM MANAGEMENT

Both institutions, jointly agree to develop and establish provisions for program implementation that will serve the mutual interests.

It is understood that the details of joint activities, conditions for utilization of results achieved, and arrangements for speci ic visits, exchanges and other forms of cooperation will be negotiated for each speci ic type of activity.

It is also understood that inancial arrangements will be negotiated in each speci ic type of

activity and will depend upon the availability of funds. Each party agrees to seek inancial resources for supporting the exchange and collaboration. The contact and exchanges between the two parties shall be on the basis of friendship, equality, and mutual assistance.

The linkage program at St Aloysius College will be under the jurisdiction of the Principal and supervised and managed by the Dean of International Programs. The program at IQS Business school, Universitat Ramon Lull will be under the jurisdiction of the Managing Director and managed by the Dean of IQS School of Management.

#### **TERMS OF UNDERSTANDING**

This understanding is effective on the date of the last signature hereto and will remain in effect for an initial period of ive years and may be extended for a period as mutually agreed by both parties. The agreement can be terminated by either institution by giving six months' notice to the other party.

The activities under this understanding will be viewed on an annual basis as mutually agreed and plans for future activities will be developed each year immediately following the review.
