



MEMORANDUM OF UNDERSTANDING

Preamble

In accordance with a mutual objective to promote further cooperation between India and the El Salvador, St Aloysius College (Autonomous), located at St Aloysius College Road, Hampankatta, Mangalore 575003, Karnataka, India, represented by its Principal - Fr Dr Praveen Martis S.J., and Universidad Centroamericana José Simeón Cañas (UCA), Bulevar Los Proceres, San Salvador, El Salvador, represented by its Rector - Fr P. Andreu Oliva S.J., agree to cooperate in regard to programs based on the principle of reciprocity. St Aloysius College (Autonomous) and Universidad Centroamericana José Simeón Cañas (UCA) are also referred to individually as a "party" and collectively as "parties".

This Memorandum of Understanding serves as a legal document for both parties to establish and develop their bilateral relationship. This academic relationship is drawn to enhance research, educational and other processes at both institutions and thereby build on their academic quality and outreach.

Objectives of the Agreement

1. Both parties will work together to develop mutual agreements for cooperation based on their respective academic, scientific and research needs. The activities in which specific agreements may be developed include:

- a. Offer of dual-degree, student exchange and study-abroad programs;
 - b. Exchange faculty members, research scholars and students at all levels;
 - c. Engage in social outreach programs;
 - d. Exchange academic information, material and programs;
 - e. Develop and implement joint research programs, including developing proposals for funding purposes;
 - f. Organize joint conferences, workshops and international training programs; and
- Other cooperative activities as appropriate.

2. St. Aloysius College (Autonomous) and Universidad Centroamericana José Simeón Cañas (UCA) jointly agree to develop and establish provisions for program implementation that will serve the mutual interests of both parties.

3. It is understood that the details of joint activities, conditions for utilization of results achieved, and other forms of cooperation will be negotiated for each specific type of activity, separately.



It is also understood that financial arrangements will be negotiated in each specific type of activity and will depend upon the availability of funds. Each party agrees to seek financial resources for supporting the exchange and collaboration. The contract and exchanges between the two parties shall be on the basis of friendship and mutual assistance.

The related work done at St Aloysius College (Autonomous) will be under the jurisdiction of its Principal and supervised and managed by the Dean of the International Programs. The program at Universidad Centroamericana José Simeón Cañas (UCA) will be under the jurisdiction of the Rector and supervised and managed by the Director of the International Relations and Cooperation Office.

Terms of Understanding

This understanding will be effective on the date of the last signature hereto and will remain in effect for an initial period of five years and will be auto-renewed for further periods of equal time, if not amended or canceled by either party. The agreement can be terminated by either institution by giving six-month notice to the other party. The projects or work started before the termination shall close to their logical end without any negative impact to either party and be amicably agreed upon by both parties.

The activities under this understanding will be reviewed on an annual basis as mutually agreed and plans for future activities be developed each year immediately following the review.
