**FRAMEWORK COOPERATION AGREEMENT BETWEEN
THE CATHOLIC UNIVERSITY OF VALENCIA "SAN VICENTE MÁRTIR"
AND ST. ALOYSIUS COLLEGE (AUTONOMOUS)**

The Catholic University of Valencia "San Vicente Mártir", hereinafter UCV, with CIF number G97025787 and registered office in C/Quevedo, 2, 46001 - Valencia, Spain, represented by its Rector, Prof. Dr. Asunción Gandía Balaguer, of the one part,

And, on the other part, St. Aloysius College (Autonomous), located at Light House Hill Road, Hampankatta, Mangalore 575 003, India, represented by its Principal, Fr. Dr. Praveen Martis S.J.

Have agreed on the following principles and conditions, which form an integral part of this Agreement.

PRINCIPLES

1. Both institutions share common academic, scientific, cultural and social objectives and interests.
2. The UCV is a higher education and research institution aiming at the social, economic and cultural development of its social environment by means of the creation and transfer of knowledge.
To this end, based on its catholic inspiration, the UCV is committed to work in this sense and believes in the growing need of cooperation between the different institutions which are committed to the social advancement.
3. Bearing in mind that the UCV and St. Aloysius College are interested in working together in the higher education sector.
4. Both the UCV and St. Aloysius College will work together in the academic and scientific fields of common interest, including the development of common projects both in the national and the international area.

Taking into account the previous principles, the UCV and St. Aloysius College agree to strengthen relations, join efforts and establish common rules to boost, in a pre-established framework, the contacts and collaborations through the following:

CLAUSES

First. Aim of the cooperation agreement

The aim of this agreement is to establish a cooperation framework between the UCV and St. Aloysius College in the fields of research, training of students, staff and the exchange of professionals and experts of different areas.

Second. Methods of the cooperation

In order to attain the goals defined in clause First, both parties commit themselves, within the framework of their capacities and that of the applicable law,

- a. to facilitate, encourage and assist each other in the development of projects and programmes of common interest within the framework of their field of activity;
- b. to organize and execute common activities related to the academic training of UCV students;
- c. to organize and execute research projects;
- d. to cooperate in training programs;
- e. to conduct activities of common interest, taking into account their respective capacities and the framework of the fields subject to the relevant projects and programmes concerned by this Agreement.

Third. Content of the cooperation agreement

The implementation of the forms of cooperation foreseen in this Agreement shall be done according to the terms of a programme defined by means of an agreement between the UCV and St. Aloysius College which shall be incorporated in a specific agreement that shall include:

- a) Definition of the target goal;
- b) Working Plan description, including the different stages and its chronology;
- c) Total budget and required human and material resources required for the mentioned Working Plan, specifying the contribution of each entity;
- d) Rules for the coordination, execution and follow-up of the plan;
- e) Names of the persons, one for each side, commonly appointed, who will be responsible for the agreement.

Fourth. Operating procedures

The collaboration raised by this cooperative agreement shall be subject to the terms of the UCV and St. Aloysius College defined by the specific agreement, taking into account the nature of the cooperation and the centre where the work would be done.

Fifth. Entry into force and duration

This Agreement shall enter into force on the day of its signing by the legal representatives of the UCV and St. Aloysius College and it shall last for four years. It shall be automatically extended for the same period of time, until any of the parties decides to put an end to this cooperation. The repudiation of this Agreement shall be notified to the other party in writing, by means of a formal letter addressed to its legal representative, and it shall enter into force not earlier than six months after its reception.

Sixth. Modifications

Both sides shall modify the agreement at any time by common agreement.

Seventh. Jurisdiction

Any dispute between the parties resulting from the development of this Agreement shall be settled amicably.

Having agreed on the above mentioned principles and clauses, the UCV and St. Aloysius College have decided to conclude this Agreement, and to this end the undersigned legal representatives have signed it on the below mentioned date.
