

MEMORANDUM OF UNDERSTANDING for cooperation between St Aloysius College (Autonomous) and Quality & Food Safety Consultants



Preamble

St Aloysius College (Autonomous) (SAC), Leated at St Aloysius College Road, Hampankatta, Mangalore 575003, Karnataka, represented by the Principal - Fr Dr Praveen Martis SJ, and Quality & Food Safety Consultants (Q&FSC), located at 98). MMR Plaza, Jakkasandra, Kormangala 1st Block Bangalore-34, Karnataka, represented by its Chief Operating Officer - Mr Ramesh Agarwal, agree to cooperate in regard to program, assed on the principle of reciprocity. SAC and Q&FSC are referred to individually as a "party" and conectively as "parties".

This Memorandum of Understanding the mafter called MOU) serves as a legal document for both parties to establish and develop their bilateral relationship. This will also help enhance research and educational processes at both institutions and thereby expand the academic spectrum of St Aloysius College and the Farm to Fork food safety and quality standards of Q&FSC.

Objectives of the Agreement

- 1. Both parties will work tog ther to develop mutual agreements for cooperation based on their respective academic, scientific and research needs. The activities in which specific agreements may be developed include.
- a) Developing and implementing joint research programs, including developing proposals for funding purposes;
- b) Increasing the index v-academic connectivity and flow in terms of placements related initiatives;
- c) Enhancing trans. e and internship opportunities for students and sharing of joint of projects to be worked on by the company and college staff;
- d) Co-organizing joint workshops and training programs;
- e) Leveraging and sharing of facilities and equipment that are unique to one institution, by the other for its research and project work;
- f) Sharing knowledge obtained from projects worked on together;
- g) Developing collaborative research and educational programs;
- h) Conducting seminars and workshops; and
- i) Other cooperative activities as appropriate.



- 2. SAC and Q&FSC jointly agree to develop and establish provisions for program implementation that will serve the mutual interests of both institutions.
- 3. It is understood that the details of joint activities, conditions for utilization of results achieved, and other forms of cooperation will be negotiated for each specific type of activity.

It is also understood that financial arrangements will be negotiated in each specific type of activity and will depend upon the availability of funds. Each party agrees to seek financial resources for supporting the exchange and collaboration. The contact and exchanges between the two parties shall be on the basis of friendship and mutual assistance.

The related work done at SAC will be under the juri dict. In of its Principal and supervised and managed by the Dean of the International Programs. The program at Q&FSC will be under the jurisdiction of the Chief Operating Officer.

Terms of Understanding

This understanding is effective on the date of the last signature hereto and will remain in effect for an initial period of five years and will be auto-renewed for the same duration of five years, if not terminated by either party. The agreement can be terminated by either institution by giving one six-months notice to the other party. The projects or work started before the termination would come to its logical end without any negative impact to either party. This will be amicably agreed upon by both parties.

The activities under this understanding will be reviewed on an annual basis as mutually agreed and plans for future activities will be developed each year immediately following the review.
