

MEMORANDUM OF UNDERSTANDING

between

St Aloysius College (Autonomous) Mangaluru

&

Yenepoya University, Deralakatte, Mangaluru

This memorandum of understanding between St Aloysius College (Autonomous) Mangaluru represented by The Principal, Rev. Fr. Dr. Praveen Martis SJ herein known as the First Party and Yenepoya University, a deemed university set up under 3(A) of the UGC act 1956, represented herein by its registrar Dr. G. Shreekumar Menon herein after known as Second Party witness as follows:

1. Whereas St Aloysius College (Autonomous), promoted by Mangalore Jesuit Educational Society (MJES), which is a well-established autonomous college with potential for excellence, having several under graduate, post graduate and research departments supporting the academic, research and extension activities in the area of regional and national interest.
2. And whereas Yenepoya University, promoted by the Islamic Academy of Education Trust, which has well known medical, dental, physiotherapy colleges and research departments where the university has now in its ambit the medical, dental, research and other allied science disciplines.
3. And whereas, St Aloysius College and Yenepoya University, of which the medical and other colleges and research departments are now a part, wish to continue the common interests of the two institutes and further develop and enrich the academic and research exchanges between their institutions.

THIS MEMORANDUM OF UNDERSTANDING WITNESSES AS FOLLOWS:

Promote activities between the departments of St Aloysius College (Autonomous) and departments of Yenepoya University in the following areas:

- A.
 1. Collaborative research, instructions and extension programs
 2. Development and implementation of joint research projects on shared fund basis
 3. Shared usage of laboratory and research infrastructure
 4. Exchange of faculty members and students for research, lectures, workshops, and discussions
 5. Joint conferences and workshops
 6. Collaborative designing of short-term academic programs
 7. Recognition of eligible academic faculty of St Aloysius College as recognized PhD supervisors under Yenepoya University as per UGC and university norms
 8. Creation of internship opportunities
 9. Engage in consultancy services
- B. Activities and programs implemented under authority of this MOU shall be subject to availability of funds and the approval of each institution's authorized representatives.
- C. Each Party will be responsible for its own cost in connection with all matters relating to collaborations under this MOU. However, where mutual advantages persist, cost may be

shared by the users on an equitable basis, or one organization may enter into an agreement with the other, subject to the regulations of each, for the supply of certain services, supplies, or equipment.

- D. The above activities will be carried out in such a manner so as not to digress from the established traditions and regulations of each Party.
- E. The terms of this MOU may be modified and amended from time to time upon agreement between two Parties.
- F. This MOU shall be initially agreed upon for a period of 5 years and be renewed automatically thereafter for a further period of five years unless notified thereto by either Party within three months of expiry thereof.
- G. Each of the above activities will be governed by specific norms to be established between Parties and coordinated by on behalf of St Aloysius College (Autonomous) Mangaluru and on behalf of Yenepoya University.

These presents shall be signed by Principal of St Aloysius College (Autonomous) and the Registrar of Yenepoya University on two sets of originals, and signed copies shall be exchanged.
