



Memorandum of Understanding

between
St Aloysius College (Autonomous)
and
Sri Neelakanteswara Natyaseva Sangha



In accordance with a mutual objective to promote cooperation between the two academic institutions in the field of art and culture and theatre, St Aloysius College (Autonomous), located at St Aloysius College Road, Hampankatta, Mangalore 575003, Karnataka (hereinafter also referred to as "SAC"), represented by the Principal – Fr Dr Praveen Martis S.J., and Sri Neelakanteswara Natyaseva Sangha, Heggodu, Honnesara Post, Sagar Taluk, Shivamogga District, Karnataka 577 417 (hereinafter also referred to as "NINASAM"), represented by the Director – Sri Akshara K.V., agree to cooperate in regard to programs based on the principle of reciprocity.

This relationship is drawn to enhance research, workshops, educational and other processes at both institutions and thereby build on their academic quality and outreach.

Both SAC and NINASAM sign this agreement on basis of mutual understanding and for the following purpose and work related to:

1. Providing a regular NINASAM schedule in the college calendar of SAC
2. Preferring and involving students and teachers of SAC in Annual Workshops of Ninasam
3. Inviting scholars attending culture workshop at NINASAM to SAC
4. Encouraging teachers of NINASAM offering short term courses for the students of SAC
5. Offering Theatre internships for students of SAC in Acting, Lighting, Music, etc.
6. Opening up of Library Fellowship for Research students in both institutes
7. Facilitating Training in Theatre for Teachers by NINASAM
8. and other initiatives that would seem to fit into this partnership

This MOU does not cover any financial transactions between the institutions and is solely an instrument and guideline for establishing a working relationship.

SAC and NINASAM jointly agree to develop and establish provisions for the program implementation that will serve the mutual interests of both parties.

It is understood that the details of joint activities, conditions for utilization of results achieved, and other forms of cooperation will be negotiated for each specific type of activity, separately, or could be based on mutual understanding and agreement under this MOU.

Terms of Understanding

This understanding will be effective on the date of the last signature hereto and will remain in effect for an initial period of five years and will be auto-renewed for further periods of equal time, if not amended or canceled by either SAC or NINASAM. The agreement could be terminated by either institution by giving six-month notice to the other. The projects or work started before the termination shall come to their logical end without any negative impact to either institution and be amicably agreed upon by both.

The activities under this understanding will be reviewed on an annual basis as mutually agreed and plans for future activities developed each year immediately following the review.
