# A TRIPARTITE MEMORANDUM OF UNDERSTANDING

of cooperation among

### Preamble

St Aloysius College (Autonomous), Mangaluru, Karnataka, represented by its **Principal, Rev. Dr Praveen Martis, SJ**, Sri Dharmasthala Manjunatheshwara College (Autonomous), Ujire, Karnataka, represented by its Principal, **Dr Satheeshchandra S,** and St Agnes College

(Autonomous), Mangaluru, Karnataka, represented by its Principal, Sr Dr M Venissa A C agree to cooperate in regard to programs based on the principle of reciprocity. St Aloysius College (Autonomous), Sri Dharmasthala Manjunatheshwara College (Autonomous), and St Agnes College (Autonomous) are referred to individually as a "party" and collectively as "parties".

This Memorandum of Understanding serves as a legal document for three parties to establish and develop their trilateral relationship. The agreement will also help in expanding their academic spectrum in terms of increased opportunities in research, and enhancement of educational processes in all three institutions.

#### The Departments Involved:

- 1. Department of English, (both UG and PG), St Aloysius College (Autonomous), Mangalore.
- 2. Department of English, (both UG and PG), Sri Dharmasthala Manjunatheshwara College (Autonomous), Ujire.
- 3. Department of English, (both UG and PG), St Agnes College (Autonomous), Mangalore.

## The Objectives of the Agreement:

- 1. All the parties will work together on mutual agreements for cooperation based on their respective academic, scientific, and research needs. The activities in which specific agreements may be developed include:
  - a. Developing collaborative research and educational programs (writing research papers, research projects, research workshops, etc.);
  - b. Exchanging of professional development programs for students, staff, and faculty;
  - c. Joint publications in literature, culture, translations, etc.;
  - d. Sharing research and library resources;
  - e. Seeking funding opportunities for joint activities that provide mutual benefit to each institution's teaching and research programs;
  - f. Co-organizing joint literary festivals, conferences & workshops, and screening international films/documentaries;
  - g. Co-organizing training in UGC NET and KSET exams;
  - h. Other cooperative activities as appropriate.
- 2. All the parties jointly agree to develop and establish provisions for the program implementation that will serve the mutual interests of each institution.
- 3. It is understood that the details of joint activities, conditions for utilization of results achieved, and other forms of cooperation will be negotiated for each specific type of activity.
- 4. It is also understood that financial arrangements will be negotiated in each specific type of activity and will depend upon the availability of funds. Each party agrees to seek financial resources for supporting the exchange and collaboration.

#### Terms of Understanding

This understanding is effective from the date of the last signature hereto and will remain in effect for an initial period of three years and will be auto-renewed for further periods of equal time if not amended or canceled by one of the parties. The agreement can be terminated by any party by giving a six-month notice to the other two parties. The projects or work started before the termination would come to its logical end without any negative impact to any of the parties involved and will be amicably agreed upon by all three parties.

The activities under this understanding will be reviewed on an annual basis as mutually agreed and plans for future activities will be developed each year immediately following the review.

The concerned institutions/involved departments, with mutual consultation, shall nominate 1. Dr Girish N of St Aloysius College (Autonomous), 2. Prof. G R Bhat of Sri Dharmasthala Manjunatheshwara College (Autonomous), and 3. Mrs Geetanjali Prabhu of St Agnes College (Autonomous), as coordinators and prepare the plan of action & monitor the activities, report and document the same.
