
- a) Exchange of academic information and sharing of academic resources.

4. This Memorandum of Understanding shall be for three years and becomes effective from September 22, 2021.
5. This Memorandum of Understanding can be evaluated every year to assess the progress and the quality outcome of the mutual cooperation.
6. This MOU may be terminated by either party with a minimum of 120 days written notice. Activities in progress at the time of termination shall be permitted to conclude as planned unless otherwise agreed.
