morandum of understanding entered into between St.Aloysius College (Autonomous) galore represented by the Principal, Rev.Fr.Swebert D'Silva SJ hereinafter known as the IRST PARTY and Jain University Bangalore, a Deemed-to-be university under section 3 of UGC act, 1956, represented by Mr. M. S.Santhosh, Joint Registrar, Jain University, hereinafter after known as the SECOND PARTY witnesses as follows.:

PREAMBLE

Whereas the FIRST PARTY, St. Aloysius College, is a well established autonomous college governed by Mangalore Jesuit Educational Society (MJES) and is recognized by UGC as a College with Potential for Excellence, having 18 postgraduate departments and 2 research centres, and as such supports research and extension activities in the areas of national and regional interest, with its Department of Postgraduate Studies in Chemistry being recognized by Tumkur University as an Advanced Research Centre,

and

Whereas the SECOND PARTY, Jain University, promoted by Jain University Trust and managed by JGI Group with its headquarters in Bangalore, has among its cluster of over 85 establishments – serving over 45000 students with a staff strength of 4500 - the Centre for Nano and Material Sciences (CNMS) a recognized research centre under Jain University,

NOW THIS MEMORANDUM OF UNDERSTANDING (MOU) WITNESSES AS FOLLOWS:

- 1. Both parties are engaged in education and research, and wish to commence and continue their common interest by developing and enriching academic and research exchanges between the two institutions.
- Both parties, in pursuance of the common intent to disseminate and advance knowledge
 intend providing instructional, research and extension facilities to each other in chemistry
 and related disciplines and thus develop academic and scientific relationship between the
 two institutions.
- 3. The collaboration between the two institutions envisaged by this MOU are:
 - (i) Collaborative research, instructional, cultural and extension programmes
 - (ii) Exchange of research information
 - (iii) Student Exchange programme
 - (iv) Faculty & Staff Exchange programme
- 4. This MOU proposes the following concrete activities in realizing the above programmes:
 - (i) Conducting Seminars and Workshops on research-related areas.
 - (ii) Organizing awareness programmes and conferences in fields of mutual interest.
 - (iii) Exchange of scientific publications.

Exchange of personnel as Resource persons

- Providing laboratory and library facilities for research activities
- (vi) Providing facilities for analysis at concessional rates
- (vii) Providing facilities for M.Sc. and research students to carry out their projects
- (viii) Organizing exchange programmes for both Staff and Students
- (ix) Conducting periodic meetings of concerned personnel to promote better understanding between the two institutions.

ADMINISTRATION OF THE MOU

- 5. The administration of this MOU will be subject to the following conditions and limitations:
 - i. The implementation of any of the programmes or activities envisaged by this MOU shall depend upon the availability of material or financial resources in the institutions concerned.
 - ii. The specifics of the programmes and activities shall be designed and carried out by the authorized representatives of the two parties.
 - The work performed under this MOU will be reviewed on an annual basis. The meetings will be held in a location and on a day that are convenient to both the institutions.
 - iv. Each party to this MOU shall own the intellectual property (IP) conceived or first reduced to practice solely by its employees or agent. Further the intellectual property conceived and reduced to practice through joint efforts of both the institutions shall be shared by both with regard to project or activities contemplated by this MOU.
 - v. Each party pledges not to use the name of other party or the name of any employee of other party, in any publicity, advertising or news release without the prior written approval of the other party.
 - vi. This MOU may be amended or modified by mutual consent by a written agreement signed by the authorized representatives of both the parties as and when required.
 - vii. This MOU commences on the day of signing by both parties involved and will remain in force for 3 years after this date. The MOU may be renewed within 30 days of its expiry by mutual written agreement, failing which it shall be deemed to have been terminated.
 - viii. This MOU may, at any time during its period of validity, be terminated by either institution with at least 3 months notice to the other party.
 - ix. The administration of this MOU will be the responsibility of both the parties or their agents or the authorized officials as the case may be.
 - x. In witness whereof the undersigned, representing their respective institutions, hereby sign and approve this Memorandum of Understanding in duplicate, one copy for every signing party.
