
MEMORANDUM OF UNDERSTANDING

St Aloysius College (Autonomous) and Father Muller College of Nursing agree to cooperate in academic exchanges and program development. This document establishes the guidelines and principles of collaboration between the two institutions.

- I. Common Interests and Objectives of St Aloysius College (Autonomous) and Father Muller College of Nursing are to provide a wide variety of educational opportunities for faculty and students of both institutions.
- II. Purpose of the Agreement
 - A. St Aloysius College (Autonomous) agrees t collaborate with Fr Muller College of Nursing by providing 30-hour workshop on "Soft Skills Training and Development".

Following Add-on program on soft skills will be taught to the B.Sc. Nursing students in St Aloysius College (Au onomous).

Department of Social Work) which involves training the students on Resume Preparation, Group Discussion, Interview Preparation and Mock Interviews will also be provided.

Assessment of the students will be done by the faculty of St Aloysius College (Autonomous).

III. Financial obligations

There will be no mancial transaction between both the parties for the said programme.

IV Evaluation meeting

A meeting will be held between the partners of the program, at the end of one academic year to have an evaluation of accomplishment of the objectives of the collaboration. The Opinionnaire from the students and faculty will be discussed and suggested modifications will be considered for the following year.

v. Term and Expiration of the Agreement

This agreement will be effective on the date it is signed by both parties, and it will be in effect for a period of three years. The validity of this MOU shall be for three years from the date of signing. However it shall be extended automatically for further periods of three years unless notified thereto by either institution to the other,

within three months of expiry of the active period. In the case of termination of this agreement, projects that have been initiated during the time this agreement was in effect shall continue with full support of the respective institutions until their completion.
