Preamble

Mangalore 575003, Karnataka, India, represented by the Principal - Fr Dr Praveen Martis S.J., and 3Di School, located at Madhya Baneshwor, Kathmandu, Nepal, represented by Mr Amar Dangi, Buisness Head agree to cooperate in regard to programs based on the principle of reciprocity. St Aloysius College (Autonomous) and 3Di School Nepal, are also referred to individually as a "party" and collectively as "parties".

This Memorandum of Understanding serves as a legal document for both parties to establish and develop their bilateral relationship. The academic relationship is drawn to enhance research, educational and other processes at both institutions and thereby build on their academic quality and outreach.

The Objectives of the Agreement

Both parties will work together to develop mutual agreements for cooperation based on their respective academic and research needs. The activities in which specific agreements may be developed include:

- Animation student-exchange programs
- Faculty exchange, collaborative Animation education at all levels
- Social outreach programs
- Exchange of online Animation & Multimedia lectures
- Exchange of academic information, material and programs
- Development and implementation of joint Animation & Multimedia programs like 2D Animation, 3D Animation & Visual Effects Projects
- Joint conferences, workshops and training programs; and other cooperative activities as appropriate

St. Aloysius College (Autonomous) and 3Di School Nepal jointly agree to develop and establish provisions for program implementation that will serve the mutual interests of both parties.

It is understood that the details of joint activities, conditions for utilization of results achieved, and other forms of cooperation will be negotiated for each specific type of activity, separately.

It is also understood that financial arrangements will be negotiated in each specific type of activity and will depend upon the availability of funds. Each party agrees to seek financial resources for supporting the exchange and collaboration. The contract and exchanges between the two parties shall be on the basis of friendship and mutual assistance.

The related work done at St Aloysius College (Autonomous) will be under the jurisdiction of the Principal and supervised by Dr Ronald Nazareth, Dean of the International Collaboration and managed by Mr Santhosh Notagar, Department of Computer Animation. The program at 3Di School Nepal will be under the jurisdiction of Mr Amar Dangi, Buisness Head, supervised and managed by Ms Srijana Pradhan, Country Head, 3Di School, Nepal.

Terms of Understanding

This understanding will be effective on the date of the last signature hereto and will remain in effect for an initial period of five years and will be auto-renewed for further periods of equal time, if not amended or cancelled by either party. The agreement can be terminated by either institution by giving one-month notice to the other party. The projects or work started before the termination shall come to their logical end without any negative impact to either party and be amicably agreed upon by

both parties.

The activities under this understanding will be reviewed on an annual basis as mutually agreed and plans for future activities developed each year immediately following the review.






