T.I.M.E. Mangalore Centre will conduct CAT 23 Coaching programme for the students of St Aloysius College as per the following terms & conditions:

**Common Admission Test (CAT2023) Coaching : The duration of the course is 220 hrs.** This course needs an average of 6 hours of classes per week. CAT23 coaching starts on 25<sup>th</sup> Feb 2023 and ends by November 2023. T.I.M.E. will provide additional support for other Management Exams in the month of December/January. Then continue to support with Group Discussion and Personal Interview training for selected students in January/February 2024. Total Course Fee is INR **28000.00** per student. The course fee is applicable only for CAT23 and for a minimum of 50 students batch size.

T.I.M.E. Mangalore Centre shall arrange faculty members to conduct classes on all the areas related to Common Admission Test and other Management Entrance Tests of Top B Schools in India.

As part of the course, T.I.M.E. Mangalore Centre shall provide Study Materials, Online tests and Model Tests in line with real exams.

T.I.M.E. Mangalore Centre is responsible for all the issues related to the course delivery. St Aloysius College will schedule the classes and inform T.I.M.E. Mangalore Centre at least SEVEN days in advance.

All the classes will be held at St. Aloysius College campus. College will provide suitable classroom with classroom equipments.

St Aloysius College and T.I.M.E. Mangalore Centre would be appointing a coordinator from both the sides to ensure smooth running of the course and better coordination.
