# MINUTES AND ACTION TAKEN REPORT OF THE FIRST ACADEMIC COUNCIL MEETING

The First Academic Council Meeting of St Aloysius (Deemed to be University), Mangaluru was held on Monday, 06 May, 2024 at 10.30 AM in Sanidhya Hall.

Rev. Dr Praveen Martis, SJ, Vice Chancellor and Chairperson of the Academic Council presided over the meeting. Rev. Dr Melwyn Dcunha, SJ, Pro-Vice Chancellor, Dr Ronald Nazareth (Registrar- St Aloysius (Deemed to be University), Dr Arati Shanbhag, Controller of Examinations were present in the meeting. 36 members of the Academic Council attended the meeting.

Rev. Dr Praveen Martis, SJ, Vice Chancellor and Chairperson of the Academic Council delivered the introductory remarks. The prayer was rendered by Rev. Dr Melwyn Dcunha, SJ, Pro-Vice Chancellor.

Rev. Dr Praveen Martis, SJ, the Chairperson, accorded a warm welcome to the members of the newly constituted Academic Council and explained the significance of the Academic Council. Dr Antony P J proposed to approve the introduction of School System and the record the appointments and the same was seconded by

Dr Narayan Bhat.

Action Taken report: The roles and responsibilities of these positions were clearly defined and documented. Regular meetings were held with the Deans to disseminate information, plan school activities, and set benchmarks. Specific targets were also established to guide each school toward continuous improvement. This comprehensive action plan has been effectively implemented to ensure the successful operation of the new School System.

**Agenda 5:** To consider the proposal to integrate BBA, MBA, BCA and MCA Programs within AICTE's jurisdiction

It is decided to incorporate the BBA, MBA, BCA and MCA programmes under AICTE under the Deemed to be University System. Uptill the academic year 2023-2024, these programmes were offered under Mangalore University.

Resolution: Approved.

Dr Denis Fernandes proposed to approve the integration of the above programmes under AICTE jurisdiction and the same was seconded by Prof. Arun Isloor.

**Action Taken report:** As per AICTE norms, approval was granted for the BBA and BCA programs with intake capacities of 320 and 310, respectively, under the university system. The request to shift the MBA and MCA programs to the university system is under consideration by AICTE, with an update expected on their website soon.

**Agenda 6:** To consider and approve the proposals of the structure of UG and PG programmes from the academic year 2024-25

The transition from Autonomous System to Deemed to be University System has resulted in a curriculum which will be executed under the auspices of the UGC Regulations under NEP 2020. The following structure was presented before the house for approval:

PG programmes will have 20 Credits per semester and in keeping with the best practices of the Autonomous Structure, the total credits for UG will be 120 and total credits for PG will be 92.

Open Electives will be offered in semesters II, III and IV. Employability Skills will be offered in semester V and internship in semester VI. Languages are offered in semesters I & II.

Resolution: Approved.

Dr Antony P J proposed to approve the structure of UG and PG programmes and Dr Hemachandra seconded it.

Action Taken report: First-year UG and PG students under the university system follow the NEP structure, including Ability Enhancement Courses, Skill Enhancement Courses (SEC), Value Added Courses (common for all UG programs), Summer Internships, and Research Projects/Dissertations. A task force has been constituted to explore options for students in the fourth year. The committee is tasked with submitting a report, based on which a plan of action will be developed.

**Agenda 7:** To consider and approve the semester I and Semester II syllabi of the programmes of eight schools.

The Deans of all the eight schools proposed the titles of the courses offered along with the syllabus (Lecture-Tutorial-Practical-Remedial) approved in their respective Boards od Studies Meetings as suggested and approved by the respective Advisory Committees. It was observed that in the Programme List, MCA has to be added. School of Commerce introduced a new programme B.Com. (Business Analytics).

The Vice-Chancellor insisted that the Deans must take initiatives to explore the operational modalities and the best practices adopted in Schools from other eminent institutions. This will enable us to revisit the courses offered and incorporate the relevant changes.

Resolution: Approved.

Action Taken report: The Semester I and Semester II syllabi for the programs of the eight schools were effectively implemented. Regular meetings of the Academic Advisory Committee were held by the departments to ensure continuous improvement. During

campus visits by eminent scientists, interactions were organized to discuss curriculum enhancements, explore operational modalities, and adopt best practices from leading institutions.

**Agenda 8:** To consider and approve the proposal from School of Arts and Humanities to start BSc (Psychology) from the academic year 2024-25

As per the curriculum flexibility desired under NEP 2020, embedded trans-disciplinary and multidisciplinary courses are encouraged. In lieu of the same, B.Sc. along with the Department of Psychology has offered the programme B.Sc. Psychology with a motive of intersecting psychological aspects in the Bio-Sciences arena.

Resolution: Approved.

Mr Gerald Colaco proposed to approve starting BSc Psychology Programme and it was duly seconded by Dr Manuel Tauro.

**Action Taken report:** B.Sc. (Psychology) program, with a second combination of Biochemistry and Zoology, was successfully launched in the academic year 2024-25 with a maximum intake capacity of 15 students. Out of the total available seats, 11 students were successfully admitted to the program, marking a positive start for this new academic offering.

**Agenda 9:** To consider and approve the proposal from School of Arts and Humanities to start M Sc in Clinical Psychology from the academic year 2024-25.

As clinical practicum component will enhance competency and enable the institution to emerge as an institute of repute in offering this programme along with the innovative mode of instruction like clinical interventions, case presentations and contemplation of action the proposal was appreciated.

Dr Aloysius Edward advised to propose the programme for 60 hours (4 Credits) and introduce Apprenticeship in the last semester.

Resolution: Approved.

Dr Chandrashekara Shetty proposed to approve the implementation of M Sc in Clinical Psychology Programme, which was seconded by Dr Udaya.

**Action Taken report:** M.Sc. in Clinical Psychology program was successfully launched from the academic year 2024-25 with an initial intake capacity of 30 students. Due to the high demand from highly competent applicants, two supernumerary seats were utilized. The total intake for the program is now 32 students.

**Agenda 10:** To consider and approve the proposal from School of Arts and Humanities to start MA in Business Economics from the academic year 2024-25

With a motive to imbibe the economic dimensions of the corporate jobs by training the students in policy making, strategically planning the financial analysis and such other components, it is pertinent to introduce this employable programme M.A. Business Economics. Mr Gerald Colaco recommended readings on 'Behavioural Economics' by Richard Taylor and Daniel Kanmann.

Resolution: Approved.

**Action Taken report:** The M.A. in Business Economics program was successfully initiated from the academic year 2024-25 with an intake capacity of 20 students. The program received a positive response, with all available seats filled, demonstrating strong demand for the programme

**Agenda 11**: To consider and approve the proposal from School of Vocational Studies to start B. Voc. in Sports Management from the academic year 2024-25.

With a perspective of health scaling, holistic grooming and achieving better career prospects in the careers as therapists and sports nutritional coaches, the School of Vocational Studies has promoted this skill bases programme. Members expressed their appreciation for proposing the innovative and career oriented programme.

Resolution: Approved.

Action Taken report: The B.Voc. in Sports Management program was launched from the academic year 2024-25 with an intake capacity of 20 students. 16 students have already enrolled, indicating a positive reception among the student community. The program has been well-received, offering students a valuable opportunity to pursue their education in the growing field of sports management

**Agenda 12:** To consider and approve the proposal from School of Information Science and Technology to start B Sc in Data Science from the academic year 2024-25

With the aspiration to promote career prospects by being a data scientist or data analyst, the School of Information Science and Technology proposed this new career oriented programme with engaging practical components.

Dr Aloysius Edward suggested that the programme be offered as an integrated programme (UG + PG).

Resolution: Approved.

**Action Taken report:** The B.Sc. in Data Science program was successfully launched from the academic year 2024-25 with an initial intake capacity of 80 students. Due to the program's high demand, two supernumerary seats were utilsed to accommodate talented applicants, bringing the total student strength to 82.

**Agenda 13:** To consider and approve the proposal from School of Commerce, Finance and Accountancy to start B. Com (Analytics) from the academic year, 2024-25

The School of Commerce, Finance and Accountancy, in collaboration with ISDC (International Skill Development Corporation), has launched the cutting edge programme, B.Com (Analytics). It was suggested to change the programme nomenclature as B.Com (Business Analytics) to make it more in tune with the current trends.

## Resolution: Approved.

Action Taken report: The B.Com (Analytics) program, launched in collaboration with the International Skill Development Corporation (ISDC) from the academic year 2024-25, has been successfully initiated with an intake capacity of 40 students. The program has experienced high demand, with all seats filled, reflecting the strong interest in this specialized field. This successful enrollment underscores the program's relevance and the value of the partnership with ISDC in providing students with industry-aligned skills.

**Agenda 14:** To consider and approve the regulations for the Degree of Doctor of Philosophy (Ph. D.) commencing from 2024-2025

In consensus with the Doctoral Committee and Institutional Research Advisory Committee, Seven Schools of Study and 49 research guides were identified. The guidelines for eligibility for the admission, duration, admission process, programme structure, assignment of the research supervisors/ guides, process for thesis submission and viva-voce, notification of Ph.D. award and revised regulations were presented.

## Resolution: Approved.

**Action Taken report:** The regulations for the Degree of Doctor of Philosophy (Ph.D.) commencing from the academic year 2024-25 were successfully implemented. Following the approval of these regulations, Ph.D. notifications were issued, resulting in an overwhelming response with 203 applications received. The Ph.D. programs are now being planned and organized in accordance with these newly established regulations,

Agenda 15: To consider and approve the structure and contents of the Course-Work for the PhD programmes

The structure and contents of the courses along with the methodology of the course work implementation duly approved by the Boards in line with the UGC guidelines and the Academic Advisory Council was proposed in the meeting. A separate committee to monitor regulations regarding Research Ethics has been constituted. Number of candidates to be admitted to the Ph.D. programmes have also been specified -Professors (a maximum of 8 candidates), Associate Professors (a maximum of 6 candidates) and Assistant Professors ( a maximum of 4 candidates). The duration of fulltime Ph.D. was proposed as 3 +1 years and of the part-time as 4+2 years.

The variation in the fee structure for full time and part time research was deliberated upon. Also, the fellowship to be offered as an incentive was also discussed.

# Resolution: Approved.

Action Taken report: The structure and contents of the course-work for the Ph.D. programs were implemented. The coursework has commenced for the 94 admitted Ph D students at both the school and departmental levels. This one-semester, 12-credit courses is scheduled to be completed in January 2025, with summative assessments planned for February 2025.

**Action Taken report:** The academic calendar for the year 2024-25 was successfully implemented, with all programs and meetings organized according to the scheduled timelines.
